

MINUTES FOR 06/17/03

Board of Aldermen

Town of Talty

I. Call to Order and Announce a Quorum

The meeting was called to order at 7:00 pm. All Board Members were present except Beth Heathington.

II. Invocation and Pledge

The invocation was led by Alderman Jeremy Benton and the pledge by Carla Milligan, Town Secretary.

III. Open Joint Public Hearing to receive citizen feedback on the following:

a. Application from Erin Amanda Smith Bowdoin to change the zoning district for Lot 6 located on Music Row in Friendly Acres from Residential One Acre (R1) to Manufactured Homes (MH);

b. Application from Dwight G. & Doloras J. Smith to change the zoning district for Lot 4 located on Music Row in Friendly Acres from Residential One Acre (R1) to Manufactured Homes (MH).

- Doloras Smith spoke on behalf of Erin Bowdoin and herself as to their desire to have the zoning changed from residential one acre to manufactured homes.
- Kenneth Cleaver spoke as to leaving the zoning as is. He stated that developers are doing business in the Town based on it's current zoning, the town incorporated to limit the impact of manufactured homes on the property values of many of the citizens living in the town. It is working well as is, and it is his desire for things to stay the same.

Before closing the public hearing, Mayor Weaver stated there are 14 site built homes and 12 vacant lots and 7 manufactured homes in this area. She discussed inquiries that she has received from other property owners in the area regarding the installation and/or upgrading of manufactured homes. She also reviewed the results of the citizen survey conducted a couple of years ago.
