

AGENDA FOR CITY COUNCIL MEETING AND PUBLIC HEARING SEPTEMBER 21, 2021

The Talty City Council will hold three Public Hearings on the fiscal 2022 Budget and proposed tax rate of \$0.240028 tax rate for 2021, and a preliminary plan for Piedmont Park Phase 1. The public hearings are scheduled to begin at 7:00 pm on Tuesday, September 21, 2021, at the Trinity Family Church, located at the intersection of FM 1641 and I-20, to consider the following:

Call to Order: Mayor Garrison will announce a quorum;

- I. <u>Open the Public Hearing on the proposed 2021 Budget</u>. Close the Public Hearing on the proposed 2021 Budget.
- **II.** <u>Open the Public Hearing</u> on the proposed \$0.240028 property tax rate for 2021; Close the Public Hearing on the proposed property tax rate for 2021;
- **III.** <u>Open the Public Hearing</u> on a request to approve a preliminary plan for Piedmont Park Phase 1, as requested by the owners design team, Pettit and Associates, LLC., who proposes to subdivide approximately 96.18 acres of land into 62 single family lots that are a minimum of one (1) acre in size situated in the Stephen White Abstract. It is within the City of Talty and generally located on the south side of *-20 and within the Stephen White Survey Abstract. The area consists of a portion of PID 16132, a 274.015 acre parcel identified as PID 16132 and a 2.13 acre parcel identified as PID 54114.

Close the Public Hearing on the preliminary plan for Piedmont Park Phase I.
