

AGENDA FOR CITY COUNCIL MEETING AND TWO PUBLIC HEARINGS OCTOBER 19, 2021

The Talty City Council will hold two Public Hearings on preliminary plans for Harvest Run Phase 1 and 2 beginning at 7:00 p.m. on Tuesday, October 19, 2021, at the Trinity Family Church, located at the intersection of FM 1641 and I-20, to consider the following:

- I. <u>Call to Order</u>: Mayor Garrison will announce a quorum and open the regularly scheduled meeting;
- **II.** <u>Invocation and Pledge of Allegiance:</u> Please rise for the invocation and pledge.

III. Open the Public Hearings on Harvest Run Phase 1

To consider the proposed preliminary plan for Harvest Run Phase 1 involving subdividing approximately 46.73 acres of land into 36 single family lots that are a minimum of one (1) acre in size. It is within the City of Talty and generally located along the northwest side of Michael Talty Avenue and CR 215, and within the Stephen White Survey Abstract (PID 16128). Close the Public Hearing on Harvest Run Phase 1;

IV. Open the Public Hearing on Harvest Run Phase 2

To consider the proposed preliminary plan for Harvest Run Phase 2 involving subdividing approximately 91.847 acres of land into 76 single family lots that are a minimum of one (1) acre in size. The location is a portion of a current 118.85 acre parcel within the City of Talty, generally located near to the west of the FM 1641 and FM 148 intersection and within the Stephen White Survey Abstract (PID 16157).
