MINUTES OF JUNE 8, 2021
CITY COUNCIL MEETING

The Talty City Council held a special meeting at 7:00 p. m on Tuesday, June 8, 2021 at the Trinity Family Church, 9670 CR 214, located at the intersection of FM 1641 and I-20, on the following:

- I. **Call to Order:** Mayor Frank Garrison called the meeting to order at 7:00 p.m. and announced a quorum. Those present were John Davis, Judy Trevino, Brad Davis and Courtney McGrath. Bobby Crowley was absent.
- II. **Invocation:** All rose for the invocation by Brad Davis. Everyone recited the Pledge of Allegiance.
- III. **Citizen Participation:** No one attended who wished to speak to the council.
- IV. **Action Items:**

Council discussed an Ordinance to Annex approximately 11.638 acres being part of the right-of-way of FM 2932, in he S. White Survey, Abstract No. 567, and the J. Moore Survey, Abstract No. 309, Kaufman County, Texas, described hereinafter in the City of Talty, Kaufman County, Texas and extending the boundary limits of the city so as to include said property within the City limits, and granting to said territory, and to all future inhabitants of said property, all of the rights and privileges of other citizens and binding aid future inhabitants by all of the acts and ordinances of the said city; adoption of a service plan, and providing an effective date.

Brad Davis made a Motion to approve Ordinance 2021-06 to annex approximately 11.638 acres being part of the right-of-way of FM 2932, in he S. White Survey, Abstract No. 567, and the J. Moore Survey, Abstract No. 309, Kaufman County, Texas, described hereinafter in the City of Talty, Kaufman County, Texas and extending the boundary limits of the city so as to include said property within the City limits, and granting to said territory, and to all future inhabitants of said property, all of the rights and privileges of other citizens and binding aid future inhabitants by all of the acts and ordinances of the said city; adoption of a service plan, and providing an effective date.

- V. **Discussion:**
 - A. **Ameri-Tex Services** presented by owner, Clayton Vickers. His associate, Arnold Bernardino was not able to attend. Ameri-Tex is the largest independent hauler in East Texas services with 14 municipal contracts.
 - B. **Blackjack Disposal**: presented by Dick Demien, and his partner is Tim Oliver. The company has been in operation since 2018. They are a locally owned company.
 - C. **Titan Waste**: presented and owned by Brian and Ashley French. Titan has been doing business in Talty and Kaufman County for over 10 years. They have cameras and GPS tracking devices in their trucks and operate twice a week pickup. Titan operates single axle trucks in compliance with Talty’s City Ordinance.

- D. **Waste Connections Lone Star:** presented by Brad Wainscott, the district manager in Dallas. Waste Connection began in 1997 and has 350 routes in the area. Waste Connections also offer twice a week pickup and operate single axle rear loader trucks.
