MINUTES OF JANUARY 17, 2023
CITY COUNCIL MEETING

The City Council held their regular scheduled meeting at 7:00 p.m. on Tuesday, January 17, 2023 at the Trinity Family Church, 107 Piedmont Path, located at the intersection of FM 1641 and I-20.

I. Call to Order: Mayor Frank Garrison announced a quorum and called the meeting to order at 7:00 p.m. Council members present were Bobby Crowley, Brad Davis, Judy Trevino and Courtney McGrath. John Davis was absent.

II. Invocation and Pledge: Brad Davis led the invocation and pledge.

III. Citizen Participation: Scott Fuhrman signed in to speak to the city council.
Scott Fuhrman brought to council's attention the drainage problem on his property 9271 Bunny Run (CR216).
He requested a meeting with the council and Mayor to resolve this issue.

IV. Action Items:

1. The Council discussed the Minutes of December 13, 2022.
A Motion was made by Judy Trevino to approve the December 13, 2022 Minutes as submitted.

2. The Council discussed the December 2022 Financial Report prepared by Murrey.
A Motion was made by Bobby Crowley to accept the December 2022 Financial Report.

Vote: 4-0; Motion carried
3. The Council discussed retiring two vehicles (1) the 2012 Chevrolet Tahoe and (2) the 2012 Dodge Charger. These vehicles are not operable and need to be sold. A notice will be posted in the Forney Messenger.
A Motion was made by Brad Davis authorizing the sale by sealed bids on the 2012 Chevrolet Tahoe and 2012 Dodge Charger.

Vote: 4-0; Motion carried
4. The Council discussed **Ordinance 2023-01 calling for a municipal election on May 6, 2023** for two council seats (Courtney McGrath and Bobby Crowley) and the Mayor's seat, each for a two year term;
A Motion was made by Brad Davis to accept Ordinance 2023-01 calling for a municipal election on May 6, 2023.

Vote: 4-0; Motion carried

5. The Council discussed contracting with Kaufman County to conduct the May 6, 2023 election. A Motion was made by Brad Davis to table this action since Kaufman County has not produced the contract to date.
Seconded: Bobby Crowley
Vote: 4-0; Motion carried

V. **Discussion:**

James Stroman, Talty's City Manager, discussed the financing of the city facility and the debt structure. The bid opening date is January 26, 2023.
