

MINUTES OF MARCH 19, 2024 CITY COUNCIL MEETING AND PUBLIC HEARING

The Talty City Council held their regularly scheduled meeting at 7:00 p.m. on Tuesday, March 19, 2024 at the new Talty City Hall, 9700 CR 213, Talty Texas.

- I. <u>Call to Order</u>: Mayor Frank Garrison called the meeting to order at 7:00 p.m. and announced a quorum. Those present were John Davis, Judy Trevino, Courtney McGrath and Brad Davis. Absent was Bobby Crowley.
- II. <u>Invocation and Pledge</u>: Brad Davis lead the invocation and all recited the pledge.
- **III.** <u>Citizen Participation</u>: No one signed in to address the council.
- **IV.** <u>Public Hearing:</u> Proposed preliminary plat on Kingsborough Phase 2 plan provides for 148 residential lots and 2 common area lots on approximately 35.528 acres. The area is in the City's extra-territorial jurisdiction and generally located on the north side of Evans Road. The area is a portion of the parcel identified as 216134 on the Kaufman Central Appraisal District website. Public Hearing was closed at 7:05 p.m.

V. <u>Discussion Items:</u>

- 1. The audit was not presented from YWRD, Inc. due to Bryan Thomas being out sick. He will mail the bound audit for fiscal year 2023 and it will be distributed at the April 2024 meeting.
